## 7. BUSINESS ARISING FROM PREVIOUS MEETING

## 7.1 Update on Annual Works Plan 2014/2015

Staff provided an update on the status of the endorsed schedule of works outlined below.

#### 7.2 Investment Funds

At the Special Committee meeting held on 10 September 2014, the Trust resolved that administrative staff, in consultation with the Chair, be authorised to seek the best short term interest rates for investing \$800,000 across two separate short term deposits with different maturity dates.

Following consultation with the Chair and the Manager Finance, two separate short term deposits have been established with maturity dates of four and six months.

## 7.3 Tour of Cemetery by Knox Historical Society

The Knox Historical Society conducted several tours of the Ferntree Gully Cemetery during Heritage Week (Thursday, 23 and Sunday 26 October, 2014). Further tours were also conducted at the end of November in conjunction with Ferntree Gully Village Discovery Day.

#### 8. ITEMS FOR DISCUSSION

## 8.1 Footpath Audit

At the Special Committee meeting held on 10 September 2014, the Trust requested that an audit be undertaken of the paths within the cemetery and that a renewal schedule be presented to this meeting.

An audit of paths in the Cemetery was last conducted in 2008. At that time a proposed year of renewal for all pathways was also identified by Council's asset management team. This data has been used as the foundation for an audit conducted by cemetery staff on 20 November 2014.

Attached at Appendix A is an aerial map of the Cemetery showing each of the paths assessed. Appendix B provides the audit data including the condition rating, estimated cost of renewal and the year of renewal based on Council's asset renewal program. Each pathway has been provided a condition rating based on the criteria established in Council's Strategic Asset Management Plan:

1 – Excellent	Asset is as new, near perfect condition
2 – Good	Asset is functional and displays superficial defects only
3 – Fair	Asset is functional and but shows signs of moderate wear & tear
4 – Poor	Asset functionality is reduced. Asset has significant defects affecting the fabric of the asset.
5 – Failed	Asset is not functional, severely deteriorated.

It is pleasing to note that no pathway has a condition rating of poor or failed. The first paths are scheduled to be replaced in 2018. However, the Trust Committee has expressed a desire to commence replacement sooner.

Based on the audit of 20 November, there is one proposed change to the condition ratings of the 2008 audit. The pathway with asset ID 610224 has deteriorated since the previous audit and is now considered to be in a fair condition as opposed to a good condition. Based on the audit, staff recommend that pathways with the following asset ID's be scheduled for replacement; Asset ID - 610506; Asset ID - 610508; Asset ID - 610223; and Asset ID - 610224.

The estimated cost for renewal of these paths is \$32,840. The renewal rate includes replacement of pathway, bedding, earthworks, reinforcement to enable equipment to travel on the paths and a 10% contingency.

Any further renewal of paths will be assessed on an annual basis as part of the scheduled program of works. The next year of renewal based on the audit would be 2023.
