Executive Summary

Knox City Council are undertaking an integrated strategic process to assess future demand for employment land to develop a future directions plan and ultimately policy recommendations for land use change in nominated business and employment land of Knox Local Government Area (LGA).

The following report is a key input into Stage 2: Strategic Review of the Land for Business project.

The report seeks to outline employment forecasts within the Knox (C) Local Government Area (LGA). The report provides industry context and integrates previous reporting, feedback from stakeholder engagement, notable industry trends and spatial analysis relevant to the Land for Business Assessment Areas.

Knox's Workforce

The estimated resident population in Knox as at June 30, 2016 is 157,052 people. Between 2006 and 2016 the local government Areas (estimated resident) population increased by 6,777 people (4.31%) with an average annual compound population growth of 0.49% over this period. Between 2016 and 2031, the population of Knox is projected to increase by 21,184 people. The average annualised projected population growth between 2016 and 2026 of 0.46% is higher than the average annualised growth rates experienced over the previous 10 years (0.38%) and the highest of the LGA's within the Melbourne East RDA.

The total number of people working in Knox (C) in all Industry sectors on Census Night 2011 was 55,807¹. This represented a -0.82% decrease in local employment between the previous 2006 Census periods. The top three employers in 2011 within Knox included:

- Manufacturing (22.5%)
- Retail Trade (13.3%)
- Wholesale Trade (11.2%)

During the previous Census period both positive and negative change was experienced across the industry sectors in terms of local employment. The most significant positive change included:

- Health Care & Social Assistance (13.4%)
- Professional, Scientific & Technical Services (23.8%)
- Construction (7.9%)

Land of Business Assessment Areas

It is estimated that 47,421 or 84.9% of jobs within Knox are located within the Assessment Areas identified for review in the Land for Business Project. Employment Land (58.8%) represent the greatest share of the employment within the Land for Business Assessment Areas, followed by the Activity Centres (20.3%), Neighbourhood Centres (14.9%), Bulky Good (3.1%) and Hospital Assessment Area (2.6%). The share of employment throughout the Assessment Areas is visually demonstrated in the Figure below.




Figure ES - 1 Distribution of employment in Knox Land for Business Assessment areass

While the Land for Business Assessment Areas contain the bulk of employment activity within Knox, the relative strengths of industry sectors across business and employment land varies. The following report provides a detailed overview of employment by industry identifying the scale of employment, structure of occupations and relative distribution of employment across each assessment areas.

Strategic Policy Alignment

Planning policy for metropolitan Melbourne identifies that the State economy is in transition and continues to evolve, in the case of Knox, this is identifiable in the local economy diversification and broader national and global markets are driving economic, business and employment growth within the municipality.

The Knox economy is a production and processing based economy with a growing component being a services and knowledge based economy. This is evident through changes to the manufacturing sector which despite job losses continues to be a recognised local strength.

Over the next 30 years it is expected that the following industry sectors will account for approximately 50 per cent of metropolitan Melbourne's employment growth:

- · Health Care and Social Assistance;
- Professional, Scientific and Technical Services; and
- Financial and Insurance Services.

While Manufacturing and Wholesale Trade industries are decreasing from an employment perspective, these industries continue to play a vital role for Knox's economic output and provision of local jobs.

The broader trends in growth of knowledge intensive industries such as Health Care, Professional, Scientific and Technical Services, and Financial and Insurance Services is expected to demand appropriate business land.

Existing key employment areas such as the Scoresby-Rowville and Bayswater (Central), Knox Central Activity Centre and Knoxfield Employment support clustering of Health Care, Manufacturing and Professional, Scientific and technical services industries. Considering the existing role of these centres is important for the Land for Business Project.

Local workforce drivers

There are range of key drivers for future employment in Knox. In summary, this includes: technology, transport infrastructure and non-assessment areas based employment.

Manufacturing is the most significant employer in the LGA. However, the sector is transitioning. Capabilities that support lower cost, but higher output businesses are increasingly driving opportunities for smaller entrepreneurial firms. Typically, smaller firms can support greater innovation and increased job creation. While demand for higher order employment is forecast (greater skills in research and development) coupled with advances in technology, it is expected that opportunities for manufacturing within Australia and locations like Knox will continue. Long term expectations for a lower Australian dollar and tapering wages growth will also boost the productivity of the sector.

The transport and logistics sector is likely to experience consolidation and automated vehicle and delivery services are forecast to be both accessible and real alternatives to support driverless movement of people and goods.

Knox is strategically located at the juncture of significant road transport infrastructure, including East Link, Mountain Highway, Burwood Highway and Ferntree Gully Road. There is significant demand for movement of the workforce both to and from the region to support economic activity. The investment in key Major Activity Centres located on the Melbourne train network facilitates the movement of both a workforce and customers, predominantly with a consumption focus. Despite forecast expansion of Knox Central Activity Centre, the limited rail network may have impacts on the role, function and performance of this centre when compared with locations such as Ringwood MAC and Glen Waverley MAC.

While most of the employment is contained within the assessment areas that are subject to this review, some sectors have representation throughout residential areas and other locations. Most notably this includes Education & Training and Construction, and to a lesser extent Health Care & Social Assistance.

Representation of both Professional Scientific & Technical Services and Other Services is also higher in locations outside of the Assessment Areas. This typically represents a proportion of self-employed or home-based business that are operating from residential addresses.

Workforce forecast approach

To determine the future workforce scale for 19 Industry sectors, consideration of the following factors was undertaken for each industry sector:

- Residential population projections by age cohort based on VIF and id forecasts
- The propensity of residents by age cohort to work
- The propensity of working residents by age cohort to work industry sectors

- ABS Labour Force Survey based projections of working residents to work in particular industry sectors
- Smoothed employment forecasts for working residents (across VIF, id and Labour Force based forecasts
- · Projections regarding the future propensity of working residents to work locally
- 'Journey to Work' linked areas' population projections and propensities for people living in these areas to work in Knox
- Land supply constraints and limitations of business expansion in relevant sectors requiring available land to increase either the scale or intensity of their operations
- Current and planned future infrastructure initiatives likely to impact the accessibility of jobs in Knox for external residents; as well as the accessibility of externally based jobs for Knox residents
- Innovation and technological advances that are enabling new business models and driving structural change.

Of note, two population forecast data sets were used to determine population workforce estimates. The figure below provides 5 yearly breakdown of the population by age group for the Knox LGA. Population projection estimates do vary between the two sets of forecasts.




Figure ES-2 Summary of Population Totals - Knox

Estimates of the population of Knox in 2011 are in the range of 154,619 to 154,623 people. By 2031 the forecast population ranges from 179,201 to 179,490 people, which represents compounding annual growth rates of 0.78 percent (VIF) and 0.78 percent (id). While the headline forecasts and growth rates align, there are notable differences year-to-year in the composition (both age and size) of the forecast population, which has significant implications for the propensity of people to be engaged in the workforce and for also for their industry sectors of employment.

Summary Forecast findings

Victoria in the Future and id population forecasts, and the REMPLAN Workforce Module have been applied to build an understanding of future residential populations, broken down by age cohort. Different age cohorts have varying propensities to be engaged in the workforce, and there are also observable


patterns in terms of employment by industry sector for respective age cohorts. For instance, young people are far more likely to be employed in sectors such as retail and food services, whereas older workers are more likely to be employed in sectors such as manufacturing, health, education and professional services.

There are also notable patterns across respective industry sectors in terms of where local residents travel to for work, and where people working in Knox reside. A broad observation is that the higher typical income levels are in a sector, the further people are prepared to travel between home and work.

Population projections by age in Knox and the surrounding Melbourne East Region, propensities to work by age cohort, complex patterns of people living in one area and working in another, structural shifts in employment over time, as well as broader strategic and situational analysis have been applied to generate 2 types of employment forecasts for Knox:

- 1. Employment Forecasts to 2036 Working Residents
- Employment Forecasts to 2036 Jobs in Knox.

Between 2011 and 2036 it is forecast that there will be 16,883 additional working residents in Knox, an increase of 22.3 percent over this timeframe.




Figure ES-4 Employment Forecasts - Jobs in Knox

Between 2011 and 2036 it is forecast that there will be 15,142 additional jobs Knox, an increase of 27.1 percent over this timeframe.

This key project input provides the basis for further assessment of land use implications across the Knox Land for Business Assessment Areas. There is a need to undertake further reconciliation of existing and future land use constraints and opportunities. Changes in the nature of employment and workforce location is an important consideration for some sectors. While most employment in the Knox LGA is located in the Assessment Areas subject to the Land for Business Project it is expected that transition and change in industry sectors will influence the demand for business land at a varying degree throughout Knox.

Integration of spatial analysis and the workforce projections within this report will be critical in determining recommendations for future land for business within Knox.

1 Introduction

1.1 Purpose and aim

Knox City Council (Knox) are undertaking an integrated strategic process to assess future demand for business land by Industry. The analysis will assist development of a future directions plan and ultimately policy recommendations for land use change in nominated business areas of Knox Local Government Area (LGA).

The Land for Business Project (LFB) includes four clear stages (Figure 1-1).

Figure 1-1 Knox Land for Business Project Stages



The following report is a key input into Stage 2: Strategic Review of the LFB project.

The report seeks to outline employment forecasts within the Knox LGA. The report provides industry context and integrates previous reporting, feedback from stakeholder engagement, notable industry trends and spatial analysis for existing business land in Knox.

Fundamentally the report has been prepared to outline likely future jobs within the LGA and nominated assessment areas based on:

- two population growth scenarios within Knox based on the State Government's Victoria in the Future (VIF), and .id forecasts
- broader East and Southern sub-region population growth projections and land use activity within metropolitan Melbourne as consolidation of industrial and business land continues in Melbourne's southeast
- projected propensities for Knox residents to work locally, as also for people residing outside of Knox to work in the area
- projected demographic changes in propensities to study and work by age cohort
- structural changes for industry sector that are being driven by innovation, technology and new business models

1.2 Methodology Overview

In preparing the LFB employment projections, REMPLAN have targeted 19 Industry Sectors and have applied the following approach:

- review population growth forecasts prepared for Council and Victoria in Future to understand future drivers of employment demand within the Assessment areas, the Knox, and the wider Melbourne East Region;
- analysis of Place of Work, Journey to Work and Place of Usual Residence data to reconcile demand for employment within Knox;
- review relevant data relating to education levels, occupations, accessibility and social disadvantage via REMPLAN Community software;
- utilise available REMPLAN datasets to establish the historic context of change across local industries with a focus on employment, output, regional exports and value-added measures;
- prepare employment forecasts taking into consideration historic ABS Census data to understand the relative level of employment and propensity to work within Knox LGA;
- establish employment forecasts based on agreed population forecast figures, regionalised small area labour force data (dating back to 1999) and REMPLANs observation of industry trends.

Further methodological insights are outlined throughout the report as relevant to the analysis.

1.3 Study Area




Figure 1-2 Knox (C) Local Government Area

The analysis presented in this report has been undertaken within the context of the Knox. This region is represented in Figure 1-2.

2 Knox Population and Economic Profile

2.1 Population

The estimated resident population in Knox as at June 30, 2016 is 157,052 people. Between 2006 and 2016 the local government area's (estimated resident) population increased by 6,777 people (4.31%) with an average annual compound population growth of 0.49% over this period.




Figure 2-1 Estimated Resident Population - 2006 2016, Knox (LGA)

2.1.1 Population Change by Statistical Area Level 2 (SA2)

Between 2005 and 2015, the population in Knox's associated SA2s increased by 6,416 people. Most population increase during this time occurred in Boronia – The Basin, which increased by 1,583 people, an annual average increase of 0.6%. Bayswater (1,336) experienced the next highest level of population increase over the 10-year period.

2.1.2 **Population Projections**

Victorian State and Local Government Area Population Projections: 'Victoria in Future (2015)' was released in 2015.

Between 2016 and 2031, the population of Knox is projected to increase by 21,184 people. The average annualised projected population growth between 2016 and 2026 of 0.46% is higher than the average annualised growth rates experienced over the previous 10 years (0.38%).




Figure 2-2 Population Projections by Age Cohort – Knox (C)

Knox commissioned population projections, have estimated the population will grow by 19,949 between 2016 and 2031 in the Knox LGA. This is 1,235 less people than estimated by the Victorian State Government projections in 'Victoria in Future' (2015). Knox population projections show that the bulk of growth in the LGA is expected in the short term between 2016 and 2018. While growth levels will diminish over the following decade through to 2027.




Figure 2-3 Population and household forecasts, 2011 to 2036, Knox


3 Employment by Sector – Historical Context

The following section provides contextual background relevant to the workforce and industry sectors in Knox.

3.1 Workforce

The total employment estimate for Knox as at the 2011 Census is 55,807 jobs. The 'Manufacturing' industry sector is the largest sector at 12,569 jobs at 22.5% of total region's jobs; followed by 'Retail Trade' (7,441 jobs) and 'Wholesale Trade' (6,240 jobs).

3.1.1 Occupation

Compared to the RDA Melbourne East and State averages, Knox has a higher proportion of 'Technicians and Trades Workers' and a smaller proportion of 'Professionals' despite 'Professionals' defining the largest occupation type.




Figure 3-2 Knox workforce occupations (%)



The workforce age profile for Knox demonstrates a strong working population between the ages of 35 – 54. Relative to RDA Melbourne East benchmark data, there is a higher level of employment for the 15 – 19 age groups (largely associated with service related employment), while younger adults (20 – 34) are supported with comparable levels of employment but significant structural differences. That is the highest level of employment amongst young adults working in Knox is associated with Manufacturing, Retail Trade, Wholesale Trade and Construction. While the same aged cohort employed across Melbourne's East demonstrate higher levels of employment in Health Care & Social Assistance, Professional, Scientific & Technical Services and Education and Training.

Between 2006 and 2011, there was a decline in the number of working residents in Knox (C). There was an overall decrease from 56,266 to 55,807 workers (- 0.82%). The resident working population experienced a large decrease overall. Workers who both work and live in the region decreased from 22,782 to 21.467 during the period representing a -5.77% decrease.

While the population of residents who work elsewhere experienced growth. There was positive change in this cohort of workers from 50,904 workers in 2006, to 54,319 in 2011 (6.71%) (Figure 3-1).

3.2 Working Residents

Between 2006 and 2011, the number of working residents decreased by (-) 1,405 people, representing a change of -7% (Table 3-2). The industries experiencing the most change between 2006 and 2011 were:

3.3 Local workforce

The total number of people working in Knox (C) in all Industry sectors on Census Night 2011 was 55,807². This represented a -0.82% decrease in local employment between the previous 2006 Census periods. The top three employers in 2011 within Knox included:

- Manufacturing (12,569 or 22.5%)
- Retail Trade (7,441 or 13.4%)
- Wholesale Trade (6,240 or 11.2%)

As outlined in Table 3-3 within the previous Census period both positive and negative change was experienced across the industry sectors in terms of local employment. The most significant positive change included:

- Health Care & Social Assistance (828 additional jobs or 13.4%)
- Professional, Scientific & Technical Services (727 additional jobs or 23.8%)
- Construction (326 additional jobs or 7.9%)

4 Industry Trends

4.1 Agriculture, Forestry and Fishing

The Agriculture, Forestry & Fishing sector contributes 78 jobs (0.1 %) to total employment. The Agriculture, Forestry and Fishing sector includes activity engaged in growing crops, raising animals, growing and harvesting timber, and harvesting fish and other animals from farms or their natural habitats. The Agriculture, Forestry & Fishing sector contributes \$24.647 million (0.12%) of total output.

The top three occupations within the sector include: Machinery Operators and Drivers (24.2 %), Technicians and Trades Workers (23.9 %) and Managers (18.5%)



4.1.1 Key Sector Insights

- The Agriculture, Forestry & Fishing sector is modest in Knox (C) employing less than 100 people.
 Employment includes some primary industry activity in locations like The Basin as well as support services that are office based.
- The sector has sustained employment loss (17 jobs in last 5 years) and relies on exporting goods and services outside of the LGA to support revenue creation.
- Demand on the *Agricultural, Forestry & Fishing* sector to increase in both scale and intensity is unlikely to demand the allocation of land within the Knox LGA context. This is particularly given the likely distance and buffering needed to support increased industrialization within the sector. That is larger areas of land are typically required to support increased agricultural output.
- While some support and consulting activity to support the sector may increase over time, it is
 unlikely the local property economics and importance of residential development and
 population driven demand for services will drive demand for increased business and
 employment land for Agriculture, Forestry & Fishing.

- It is estimated that 48 jobs in the sector are in Assessment Areas relevant to the LFB project.
 This represents 61.5% of employment in the sector.
- The spread of employment activity is across the relevant employment land is outlined in Figure 4-2

Figure 4-2 Knox LFB Assessment Areas supporting Agriculture, Forestry & Fishing jobs



4.2 Mining

The *Mining* sector contributes 47 jobs (0.1 %) to total employment. The top three occupations within the sector include: Machinery Operators and Drivers (49.9 %), Managers (33.4 %) and Clerical and Administrative Workers (9.3 %).

4.2.1 Key Sector Insights

- The Mining sector with the Knox LGA contributes \$36.944 million (0.2 %) of total output.
- There is some structural change underway, including decommissioning of a Boral mine within the LGA.
- Most the local employment in the sector is associated with Gravel and Sand Quarrying, Other Construction Material Mining or Non-Metallic Mineral Mining and Quarrying.

- Expenditure through local supply chains have declined over the past five years from \$11.130 million to \$6.814 million.
- The sector supports local construction activities.
- Given the surrounding high value residential land uses it is unlikely the sector will grow significantly and create demand for new mining land
- There is opportunity for land no longer required for mining to provide additional supply for other business/employment land use.
- 22 Mining sector jobs (46.8 %) are in the LFB Assessment Areas. They are outlined below in Figure 4-4.

Figure 4-4 Knox Employment Assessment Areas supporting Mining jobs





4.3 Manufacturing

The Manufacturing sector contributes 12,569 jobs (22.5%) to total employment. It is the largest employer within the Local Government Area. The Manufacturing sector within Knox includes several manufacturing sub sectors that are considered 'Key Propulsive Industries' within Knox. This includes: Professional, Scientific, Computer & Electronic Equipment. Manufacturing; Human Pharmaceutical Product Manufacturing & Specialised & Other Machinery & Equipment Manufacturing which combined contribute around 2,871 jobs (5.1%) of local employment.

The top three occupations within the sector include: Technicians & Trades Workers (21.4%), Managers (17.1%) and Labourers (15.3%) (Figure 4-5).



4.3.1 Key Sector Insights

- Despite a downward trend across a number of manufacturing industry classifications, a range of
 Manufacturing sectors within Knox are of strategic importance because of their employment
 base, contribution to regional exports and strong alignment with current Victorian State Industry
 Policy.
- In 2011, the Manufacturing sector was the largest local employer within Knox LGA and supports 12,569 jobs.
- Manufacturing sector in Knox contributes \$9.114 billion (45.2 %) of total output. Total revenue
 for the sector has been in decline. Despite this, the sector remains the largest sector in terms of
 total revenue.
- The Manufacturing sector has experienced decline in most key economic indicators (Output, Value-added & Local Expenditure), albeit reductions in scale of a modest level compared with other manufacturing sectors with higher volatility.
- There is a demonstrable ongoing strength in regional exports from the sector, particularly associated with Technical Equipment & Appliance Manufacturing that represents 22.4% of total regional exports.
- Significant transition in the Manufacturing sector is relevant to broader National performance of
 the sector. Despite this, manufacturing businesses located in Knox are well positioned to drive
 growth in the sector, strongly aligned to current Victorian Government Industry Policy and macro
 trends towards knowledge intensive manufacturing driven through technological innovation.
- There has been a reduction of \$384 million in terms of the sectors contribution to Gross Regional Product (Value-added). However, compared with other manufacturing regions this reduction is relatively modest demonstrating Knox's manufacturing sector resilience and alignment with the sectors transition from labour intensive to knowledge intensive output.
- All local manufacturing employment is located within the LFB Assessment Areas. Bayswater (Central) is the most significant LFB employment land for the sector due to the scale of employment. The Bayswater (Central) supports 3,832 manufacturing jobs, or 30.5 %) of total manufacturing employment within Knox at 2011 Census.
- Modelling of total output by industry within the manufacturing sector indicates a positive compounding annual growth rate between 2011-2016 within the Dairy Product Manufacturing (11.05%); Knitted Product Manufacturing (16.77%); Natural Rubber Product Manufacturing (18.37%); Glass & Glass Product Manufacturing (22.40%); Structural Metal Product Manufacturing (2.45%); Professional, Scientific, Computer & Electronic Equipment Manufacturing (5.18%) & Domestic Appliance Manufacturing (28.84%).

4.4 Electricity, Gas, Water and Waste Services

The *Electricity, Gas, Water & Waste Services* sector contributes 279 jobs (0.5%) to total employment. The top three occupations within the sector include: Technicians & Trades Workers (31.7%), Machinery Operators and Drivers (19.1%) and Clerical and Administrative Workers (17.0%).

4.4.1 Key Sector Insights

- The *Electricity, Gas, Water & Waste Services* has sustained continued economic growth across all key economic indicators with total Output estimated \$198.216 million 1.0% of total output.
- It is anticipated the sector will continue to grow to support population and industry demand within the region and Knox LGA.
- While these broader economic activity is likely to demand utilities locally, it is unlikely they will
 drive significant demand for business/employment land.
- New forms of utilities that are distributed may have a role in demand for business land potentially associated with new buildings (eg. Leasing of roof space for solar).
- It is estimated that 184 jobs (65.95 %) of the *Electricity, Gas, Water & Waste Services* sector employment are located in LFB Assessment Areas.
- The balance of employment in the sector are located outside the LFB Assessment Areas in locations such as AusNet Services Rowville Terminal Station and Area Centre Depot.


Figure 4-8 Knox LFB Assessment Areassupporting Electricity, Gas, Water & Waste Services jobs

4.5.1 **Key Sector Insights**

- The *Construction* Sector has sustained strong growth across all key economic indicators with total Output estimated at \$1.777 billion representing 8.8% of total output.
- Construction Services (building trades) are responsible for \$8.41.679 million (47.4%) of the sectors total output.
- The Construction sector is renowned for strong local supply chains that support demand for goods and services within Knox (C) across the key industry sectors of Construction and Manufacturing (approximately \$733.343 million combined)
- There are significant business entries (and change) associated with the Construction sector. Of
 note, business listed for GST within the Construction Services (construction trades eg.




Figure 4-10 Annual Construction Industry Businesses listed for GST – Knox (C)

 Carpenters, Electricians, Plumbers & Painters) sustains year on year growth (Figure 4-10).

- Construction related employment is spread widely across the Knox LGA and the LFB Assessment Areas. Jobs are located within all the key Employment lands with the exception of the HP-01 Wantirna Hospitals and the Strip Shops.
- The employment total of 3332 within the dedicated assessment areas only represents 81.23% of total employment within the sector. That is, while the sector supports decentralised activity (on site), there is strong demand for employment land to support Construction sector jobs.
- Bayswater (Central) (Mountain Highway, Power Road) supports the highest number of jobs within the *Construction* Sector (594 or 14.5%).

4.6.1 **Key Sector Insights**

- Wholesale Trade sector has experienced decline in economic activity over the last four years but remains an important and resilient industry sector within the Knox local economy.
- Between 2006 and 2011 the sector shed 603 jobs impacting on wages and salaries growth and reflecting a total reduction local expenditure and income generated through regional exports.
- Local sales to the Manufacturing sector represent 48.7% of Wholesale trade within Knox (C).
- Broader regional decline in the sector reflects increasing automation and structural adjustment following period of higher value Australian dollar.
- The overall reduction in total output from \$2.444 billion to \$2.171 million over the last four years
 has also seen reduction in wages and salaries, local expenditure and the sectors contribution to
 Gross Regional Product (Value-added).
- Both the Bayswater (Central) and Caribbean Business Park are the anchors for Wholesale trade
 jobs in Knox and represent 49% of local jobs in the sector. While Knoxfield Employment supports
 another 12% of local jobs (Figure 4-13).





4.7.1 Key Sector Insights

- The Retail Trade sector is significant within Knox and supports the second highest level of employment with over 7,441 jobs or 13.3% of total employment in Knox.
- The Retail Trade sector contributes \$827.963 million (4.1 %) of total output.
- Over the past five years, the Retail sector has remained resilient experiencing a reduction in overall output between 2011 and 2014 before demonstrating growth in total revenue during the last two years.
- Wages and salaries are estimated to have responded to the total sales revenue represent 7.9% of total wages and salaries in in Knox, or \$316.988 million.
- While retail is a significant contributor to Knox's visitor economy, the sector continues to service
 local demand and need of the resident population. Regional exports are estimated to have
 reduced from 2011 levels of \$67.991 million to \$39.214 million. This reflects expansions of other
 major retail centres throughout the Melbourne East RDA that primarily service local community
 and business needs.
- The workforce is generally less skilled and contains a greater proportion of part-time female workers. For example, 24.6% or 2,339 of the workforce work between 1 15 hours per week. Of these part-time workers, 31.6% are male and 68.4% are female.

Knox Central Activity Centre is the key retail district supporting 1,825 jobs (24.5%) with the role
of the other Activity Centres, Bayswater (Central) and Mountain Gate Central comprising 40.4%
of retail employment across the LGA.

4.8.1 Key Sector Insights

- The sector supports many workers (8th largest in LGA) but employment is concentrated in lower paid part-time employment.
- 34.5% of workers in the sector are paid less than \$199 per week, while 1,100 of the 2,848 jobs are part-time work between 1 – 15 hours per week.
- Total output has declined from 2011 levels of \$336.417 million to an estimated \$314.626 in 2016.
- Knox Central Activity Centre is the focus for employment in the sector and supports 23.9 % of all
 employment in the sector.
- There is representation of the sector across the Activity Centres, Neighbourhood Centres and Employment land. The combined Neighbourhood Centres comprise 23.9% of total employment in the sector and are expected to sustain modest growth from a lower base. Essentially supporting greater opportunities for accommodation and food options to meet local community requirements.




Figure 4-17 Knox LFB Assessment Areas supporting Accommodation & Food Services jobs

4.9.1 **Key Sector Insights**

- The Transport, Postal & Warehousing sector is experiencing significant advances in technology that is driving demand for higher order employment and less labour intensive roles in drivers and administration.
- The *Transport, Postal and Warehousing* industry sector within Knox has seen reduction in overall economic activity in terms over the last five years.
- Knox LGA is highly dependent on local road assets such as East Link and Burwood Highway, that
 have strategic importance for economic activity and employment. Road assets provide greater
 access to Melbourne's regions that have consolidated in recent years within the *Transport*, *Postal*& Warehousing industry across Melbourne's outer East, North and West. Greater access
 generates greater capacity to service the entire State from these logistics hubs.
- The sector is represented across most of the LFB Assessment Areas. Concentration of activity
 is within the Employment Land of Knoxfield Employment and Bayswater (Central) which support
 487 jobs or 33.1% of total employment locally.
- Longer term expansion of this industry is likely to be associated with East-Link. The extent to
 which the industry may experience growth within Knox is dependent on the scale of land use to
 support Transport, Postal & Warehousing uses in association with East-Link particularly. The
 extent of available employment land for these industries will be important. In summary, unless

land is available in Knox close to East-Link it is expected employment within the sector will be located outside of the municipality.






Figure 4-21 Knox LFB Assessment Areassupporting Information Media & Telecommunications jobs

- The Financial & Insurance Services sector contributes \$555.911 million (2.8 %) of total output.
- Total sales revenue (Output) has declined over the last five years from 680.145 million to an estimated \$555.911 in 2016.
- This decline has impact on the sectors performance and contribution toward wages and salaries and gross regional product (Value-added).
- However local expenditure in 2016 has returned to levels slightly above 2011 demonstrating strong links to other local professional services and collaboration between the finance and banking sectors within the broader *Financial & Insurance Services* sector.




Figure 4-23 Knox LFB Assessment Areassupporting Financial & Insurance Services jobs




Figure 4-24 Rental, Hiring & Real Estate Services (Jobs) – Knox (C), ABS 2011

- The Rental, Hiring and Real Estate sector is strongly linked to a growing residential population, the increasing value of property assets in the Knox (C) economy.
- The sector is modest in terms of overall employment. While total employment is low, the industry output (total sales revenue) continues to increase in is currently estimated at \$1.592 billion
- Rental, Hiring and Real Estate includes 'Ownership of Dwellings' which reflects housing stock in Knox (C) and the significant demand this generates for local goods and services including Financial & Insurance Services (\$131.747 million), Construction (\$59.248 million) and Professional, Scientific & Technical Services (\$22.974 million).




Figure 4-25 Knox LFB Assessment Areassupporting Rental, Hiring and Real Estate jobs




Figure 4-26 Professional, Scientific & Technical Services (Jobs) – Knox (C), ABS 2011

4.13.1 Key Sector Insights

- The Professional, Scientific & Technical Services sector contributes \$795.651 million (3.9 %) of total output. The sector is the 6th largest sector in terms of total revenue. Total output by the sector increased significantly between 2011 and 2013 and has now stabilised at almost \$800 million per annum.
- Growth in wages and salaries has responded to the increased revenue in the sector locally.
- While professional services as a regional export have not increased markedly, local sales represent 75.7% of total sales revenue. This indicates strong local demand for Professional, Scientific & Technical Services within the local economy. That is local firms are delivering for local clients.
- The Professional, Scientific & Technical Services sector contributes \$244.580 million (4.5 %) of total local expenditure. Across the Melbourne East Region, the sector contributes 9.2% of total local expenditure. As such there appears to be greater opportunity for increased local expenditure to support aligned business activities through strategies of collaboration, clustering and partnering.
- The sector is experiencing change that is being driven by technological advances and new business models, which present collaboration and partnering opportunity for computer and technical service related businesses with the broader *Professional, Scientific & Technical Services* sector
- The technological advances and new business models driving change in this sector are to varying degrees impacting all of Knox's key industries; strong representation of businesses in Knox across Engineering, Accounting, Management Consultancy and Computer System Design all indicate continued growth in the Professional, Scientific & Technical Services employment.
- Employment in the Professional, Scientific & Technical Services sector is spread across most of the LFB Assessment Areas. The strongest representation is within the Activity Centres and Employment Land. Bayswater (Central) supports 457 jobs (14.97 %) while the Caribbean Business Park (11.2%), Knox Central Activity Centre (9.5%) and Boronia Activity Centre (7.5%) account for another 866 jobs in the sector.




Figure 4-27 Knox LFB Assessment Areas supporting Professional, Scientific & Technical Services jobs

- The Administrative & Support Services sector contributes \$332.837 million (1.7 %) of total output.
 Total output by the sector increased by \$50.060 million between 2011 and 2016, although growth fluctuated throughout the period.
- Wages and salaries shadowed the sectors revenue performance and is estimated to be \$142.989 million or 3.5% of total wages and salaries.
- While modest, the sector has grown its local expenditure with strongest local supply chains evident across Rental, Hiring & Real Estate Services (\$10.816 million) and Professional, Scientific & Technical Services (\$24.765 million).



4.15.1 Key Industry Insights

- The *Public Administration & Safety* sector contributes \$316.936 million (1.6 %) of total output and has increased from \$262.198 million in 2011 to \$316.936 million in 2016.
- Wages and salaries growth has matched the estimated increase in total output by the sector.
 The Public Administration & Safety sector contributes \$149.917 million (3.7 %) of total wages and salaries.
- Demand across all levels of Government and key public order functions associated with police and fire services continues to grow with the need for service provision to align with an expanding resident base.
- All key economic measures have grown between 2012 and 2015 reflecting larger government budgets and an expanding workforce to meet the service needs of an expanding region
- The *Public Administration & Safety* sector contributes \$180.192 million (2.4 %) to Gross Regional Product (Value-Added).
- It is expected that ongoing demand for services and infrastructure to support the liveability of a growing and ageing population base in Knox (C) will propel ongoing industry expansion.

• The role of the Knox Central Activity Centre is significant in supporting employment and economic activity for the sector. The Activity Centre supports 49.53% of all employment in the sector (Figure 4-27).

Figure 4-31 Knox LFB Assessment Areas supporting Public Administration & Safety jobs






4.16 Education and Training

- The Education & Training sector contributes \$259.254 million (3.5 %) of total value-added.
- Education & Training sector contributes \$344.591 million (1.7 %) of total output.
- The sector is the 6th largest employer in the LGA, supporting over 3000 jobs.
- Sustained job growth and increase in wages & salaries is strongly aligned to a growing population and demand for access to education through tertiary years.
- As demonstrated by in Table 4-16, the sector has experienced ongoing growth in wages and salaries, its contribution to Gross Regional Product (Value-added).
- While there is representation of the sector in the LFB Assessment Areas, it represents only 19.36% of total employment. Many schools and other educational institutions are located outside of the LFB assessment areas, including Pre-Schools, Primary Schools, Secondary Colleges and Swinburne University.



4.17.1 Key Sector Insights

- The Health Care & Social Assistance sector contributes \$652.792 million (3.2 %) of total output. Total Output has increased from 2011 levels, but has seen an overall reduction since 2013.
- The sector is significant in terms of employment (11.1%) and as a contributor to Gross Regional Product (6.7%) (Value-added).
- The sector has experienced sustained increase in wages and salaries, contributing \$417.565 million (10.4 %) of total wages and salaries.
- Despite a reduction in overall output, the sector contributes strongly to Gross Regional Product (Value-added), \$500.097 million or 6.7% of Knox's total contribution.
- Health Care and Social Assistance is strongly aligned to demands of a growing and ageing population; it is expected this sector will continue to support significant local employment opportunities.
- Employment and activity is centred around the Wantirna Hospitals Assessment Areas. It is estimated that this cluster of employment represents 1,253 jobs or 20.30% of sectors total employment in Knox (Figure 4-35).
- Beyond Knox Private Hospital this key regional Health location, the role of the Activity Centres
 and Bayswater (Central) are also significant in supporting a range of employment in the sector.

 Some key locations, such as Angliss Hospital (934 jobs) are in locations outside of the LFB Assessment Areas.

Figure 4-35 Knox LFB Assessment Areas supporting Health Care & Social Assistance jobs






4.18 Arts and Recreation Services

4.18.1 Key Industry Insights

- The Arts & Recreation Services sector continues to show growth in total output (sales revenue) albeit from a relatively low base. The sector contributes \$41.314 million (0.6 %) of total valueadded.
- Wages and salaries growth have fallen in recent years. Despite wages and salaries decreases
 across the sector, the Arts and Recreation Services sector contribution to Gross Regional Product
 has grown and remained steady over the last six years.
- The contribution of the Arts and Recreation sector to Gross Regional Product has grown over the last four years but plateaued to \$72.6 million
- The strength of local supply chains with the sector is evident through local expenditure that has
 grown over the last four years to over \$49.161 million; these links are estimated to be strongest
 with local Manufacturing, Professional, Scientific & Technical Services, Administrative & Support,
 and other Arts & Recreation Services.
- Boronia Activity Centre sustains an estimated 150 jobs or 22.5% of total Arts & Recreation Services Sector employment. Most workers in the Boronia Activity Centre are associated with employment in recreation supporting local demand for health, fitness and gyms.




Figure 4-37 Knox LFB Assessment Areas supporting Arts and Recreation jobs

4.19 Other Services

The *Other Services* sector contributes 2,401 jobs (4.3 %) to total employment. *Other Services* includes a broad range of personal services; religious, civic, professional and other interest group services; selected repair and maintenance activities; and private households employing staff.

The top three occupations include: Technicians and Trades Workers (52.6%), Clerical and Administrative Workers (13.5%) and Community and Personal Service Workers (9.5%).

4.19.1 Key Sector Insights

- The Other Services sector contributes \$322.539 million (1.6 %) of total output. The sectors overall revenue has declined since 2011/12 levels but has steadily increased since 2013.
- Despite an overall reduction in total sales revenue (output), wages and salaries have increased \$110.734 million (2.7 %) within Knox.
- The sector contribution to Gross Regional Product (Value-added), has increased over the last six years and now represents \$162.739 million (2.2 %)
- Services captured within the sector (eg. Automotive Repair and Personal Services) are aligned to demand of the local resident population. The Other Services sector sells \$146.851 million of final goods per annum into the Household Consumption sector, in Knox (C).
- The LFB Assessment Areas represent a significant proportion of total employment in the sector (2012 jobs or 83.8%). There is a broad representation of Other Services jobs across the LFB Assessment Areas with a 14.57% of Automotive Repair & Other Repair and Maintenance employment located in the Bayswater (Central) (352 jobs). Other key Assessment Areas include Knox Central Employment, Mountain Gate Industrial Estate, Rowville (Kelletts Rd) and Mountain Gate Central that combined represent 24.1% or 579 jobs.

5 Strategic Issues for Knox

5.1 Policy

Urban Enterprise have completed a literature review and undertaken strategic engagement with key industry stakeholders relevant to business and industrial land in Knox.

The key issues of relevance to the employment projections for Knox include:

- Planning policy for metropolitan Melbourne identifies that the State economy is in transition
 and continues to evolve. In the case of Knox, this is identifiable in the local economy
 diversification and broader national and global markets are driving economic, business and
 employment growth within the municipality.
- The Knox economy is moving from a production and processing based economy to a services/knowledge based economy. This is evident through the manufacturing sector which is recognised as a local strength.
- Over the next 30 years it is expected that the following industry sectors will account for approximately 50 per cent of metropolitan Melbourne's employment growth:
 - Health Care and Social Assistance;
 - o Professional, Scientific and Technical Services; and
 - Financial and Insurance Services.
- While Manufacturing and Wholesale Trade industries are decreasing from an employment perspective, these industries continue to play a vital role for Knox's economic output and provision of local jobs.
- The broader trends in growth of knowledge intensive industries such as Health Care, Professional, Scientific and Technical Services, and Financial and Insurance Services is expected to demand appropriate business land.
- Existing key employment locations such as the Scoresby-Rowville and Bayswater (Central),
 Knox Central Activity Centre (ACO2) and Knoxfield Activity Centres (EPO3) support clustering of
 Health Care, Manufacturing and Professional, Scientific and technical services industries.
 Considering the existing role of these centres is important for the Land for Business Project.

5.2 Technology

- Manufacturing capabilities that support lower cost, but higher output businesses are increasingly driving opportunities for smaller entrepreneurial firms. Noted for their ability to rapidly support expansion, the role of smaller firms within Knox to support increased job creation is anticipated across the manufacturing sector as applications of technology continues to intensify while simultaneously costs are reduced. Increased opportunities to replace labour costs through technologies including robotics and 3D printing will promote local renewed opportunities for manufacturing within Australia and locations like Knox. A lower Australian dollar and tapering wages growth will also boost the productivity of the sector.
- Automated vehicle and delivery services (e.g. Drones) are forecast to be both accessible and
 real alternatives to support driver less movement. Subject to regulation and associated safety,
 the demand for increased mobility of goods and services is expected to continue and will be
 supported in growth of the transport and logistics sector.

5.3 Transport Infrastructure

 Knox is strategically located at the juncture of significant road transport infrastructure, including East Link, Mountain Highway, Burwood Highway and Ferntree Gully.

- Rail access is limited with some access in the north-eastern area of the LGA via the Belgrave Rail
 line. This includes passenger railway stations at Bayswater, Boronia and Ferntree Gully.
 Significant areas of the LGA are not serviced by rail.
- There is significant demand for movement of the workforce both to and from the region to support economic activity. The investment in key Activity Centres located on the Melbourne train network facilitates the movement of both a workforce and customers, predominantly with a consumption focus. Despite forecast expansion of Knox Central Activity Centre, the limited rail network may have impacts on the role, function and performance of this centre when compared with locations such as Ringwood MAC and Glen Waverley MAC.
- The focus on road transport for employment favours both increased levels of contained employment (residents who work locally in Knox) and a workforce derived from locations (LGA's) adjoining Knox.

5.4 Employment outside of Assessment Areas

- While most of the employment is contained within the LFB Assessment Areas that are subject to
 this review, some sectors have representation throughout residential and other locations. Most
 notably this includes Education & Training and to a lesser extent Health Care & Social Assistance.
- Sectors that have limited impact on the Land for Business Strategy in terms of driving demand for business land include the Agricultural, Forestry and Fishing and Mining Sector.
- Representation of both Professional Scientific & Technical Services and Other Services is also higher in locations out of business and employment land. This typically represents a proportion of self-employed or home-based business that are operating from residential addresses.

6 Employment - Trends & Projections

A methodology has been applied to estimate employment trends and projections based on datasets from the Australian Bureau of Statistics and population projections prepared by the Victorian State Government and id consulting.

These include:

- 6291.0.55.003 Labour Force, Australia, Detailed, Quarterly, from August 1999 to Feb 2016
- · ABS, 2006 and 2011 Census of Population and Housing,
- Victoria in Future 2015
- Knox City Council Population Forecasts, prepared by id Consulting

Population estimates for each year from 2011 to 2031 have been sourced from the following dataset:

- Estimated Resident Population (ERP) for Local Government Areas (LGAs) and Victoria in Future Small Areas (VIFSAs) by five-year age group and sex, for every fifth year from 2011 to 2031
- Knox City Council, Population forecast Population and age structure, id Consulting

Workforce by age-cohort's data for each industry sector has been sourced from the following:

- ABS, 2006 and 2011 Census of Population and Housing
- REMPLAN Workforce Analysis Module.

6.1 Regionalisation and Assumptions

The Labour Force survey data outlined above, which is relevant to Knox LGA, is only available at the broader geographic level known as Melbourne East ASGS³. A methodology has been applied to 'regionalise' this data to make it specific to Knox (C). 2011 Place of Usual Residence employment by industry data was sourced for the combined local government areas and SA2 Regions relevant to Melbourne East ASGS. The data was used to create region and industry specific coefficients, which were applied to Labour Force data, providing estimates of the regionalised employment by industry data for Knox (C) LGA.

The quarterly Labour Force Survey data was applied from August 1999 to February 2016. This dataset makes no inference about where a person works, only that they were surveyed in the defined area. Since the Labour Force Survey is a sample-based publication, fluctuations in data can occur and should be approached with caution⁴.

Population estimates by age cohort have been obtained for Knox LGA for the period from 2011 to 2031⁵. A methodology has been applied to create industry specific coefficients for each age group. ABS, 2006 and 2011 Census of Population and Housing, Working Population Profiles were used to determine the proportion of each age group of the population who participate in the workforce.

It is projected that subtle structural changes in the propensities of people to work across respective age cohorts will change over time. Namely, that as the economy moves over time to a greater proportion of 'thinking' jobs, some younger people in the 15 -24-year cohort will delay entering the workforce in preference of longer periods of study. Also, as we track forward to 2036 the proportion of people over 60 years will increase and it is estimated that a greater number of people in older age cohorts will be engaged in the workforce for longer. These assumptions have been applied to the employment forecast model.

Estimates of employment based on Labour Force survey data and estimates of employment based on population forecasts have been combined to generate a 'smoothed' trend line projecting the expected level of employment in each industry over the period 2011 to 2031. This approach reconciles the demand side estimates from the ABS Labour Force Survey data with the supply side data from the two population growth scenarios (i.e. how many people are we likely to have to fill the projected jobs).

In addition to employment forecasts of Knox (C) residents, population and employment forecasts for the wider Melbourne East Region, and Journey to Work patterns encompassing the propensities of Knox residents to work locally and external residents to work in Knox, were applied to generate Place of Work employment forecasts for 19 industry sector. That is, forecasts of the number of jobs in Knox.

In general terms, id consulting forecast higher growth rates across younger age cohorts throughout the forecast period, while the VIF forecasts are comparable in terms of total population by 2031 but have a higher proportion of residents who are above 60 years old. As an example, by 2031 the VIF forecast 9,201 more residents over the ages of 60 years old than id consulting.

The composition (both age and size) of the forecast population significantly alters the propensity and type of workforce engagement that can be expected within a given region.

Estimates of the population of Knox in 2011 are in the range of 154,619 to 154,623 people. By 2031 the forecast population ranges from 179,201 to 179,490 people, which represents compounding annual growth rates of 0.78 percent (VIF) and 0.78 percent (id).




Figure 6-2 Summary of Population Totals - Knox

This approach for the respective industry sectors has generated a forecast employment range. Considering local and macro factors, regional strategies and plans, major projects and the State Government's nominated priority sectors, specific employment projections have been generated within the respective sectors' forecast employment range.

The specific projection with the forecast range is signified by " 🔃 in the graphs below.

6.1.1 Agriculture, Forestry & Fishing (working residents)

In 2011 there were 153 Knox residents employed in the 'Agriculture, Forestry & Fishing' industry sector. By 2021 employment is estimated to be 129 jobs. By 2036 the number of jobs is projected to be 133, reflecting a stable to low-growth outlook, off a very small base in the context of Knox.




Figure 6-3 Agriculture, Forestry & Fishing: Employment Trend Lines (Working Residents)

In 2011 there were 78 'Agriculture, Forestry & Fishing' industry sector jobs in Knox. By 2021 employment is estimated to be 68 jobs. By 2036 the number of jobs is projected to be 72, reflecting a stable to low-growth outlook, off a very small base in the context of Knox.




Figure 6-5 Agriculture, Forestry & Fishing – Knox Workers, Top 5 LGAs of Usual Residence






Figure 6-7 Mining: Employment Trend Lines (Working Residents, Jobs)





By 2036 it is forecast that there will be 52 *Mining* sector jobs based in Knox, which represents a 10.6 percent increase from the relatively low base of 2011 levels. The combination of constrained land, reduction of operations and larger operations in the Greater Melbourne region are anticipated to limit the sectors expansion. While ongoing forecast population growth is estimated to drive demand for residential and civil engineering construction activity, which in turn will support local sand and gravel quarrying, which is part of the broader mining sector.

6.1.5 Manufacturing (working residents)

In 2011 there were 10,791 Knox residents employed in the 'Manufacturing' industry sector. The 2021 employment is estimated to be 10,737 jobs. By 2036 the number of jobs is projected to be 9,928, reflecting a decline in employment and in the context of population growth, a significant drop in manufacturing's proportionate contribution to supporting employment for residents.

It is important to note that the graph below does not reflect the volatility of structural change that will continue to occur in this sector through to 2036. Many jobs will be lost in sectors such as motor vehicles and parts; however, many jobs will also be generated in other areas of manufacturing. The 'smoothed' trend line below is an estimate of the net position once losses and gains are taken into consideration.




Figure 6-11 Manufacturing: Employment Trend Lines (Working Residents)



Figure 6-12 Manufacturing Sector - Resident Working Population, Top 5 LGA 's of Usual work





Employment in 'Manufacturing' is support by an estimated 833 businesses within the Knox LGA which are currently trading with registered ABNs and listed for GST (Figure 6-6). 


Figure 6-14 Manufacturing: New Businesses entries between 1st July 2011 and 1st May 2016

Figure 6-15 Electricity, Gas Water and Waste Services: Employment Trend Lines (Working Residents)






Figure 6-16 Electricity, Gas Water & Waste Services Sector - Resident Working Population, Top 5 LGA 's Usual work










Figure 6-20 Construction: Employment Trend Lines (Working Residents)




Figure 6-23 Construction: New Businesses entries between 1st July 2011 and 1st May 2016




Figure 6-26 Wholesale Trade - Knox Workforce, Top 5 LGAs of Usual Residence




Figure 6-27 Wholesale Trade: New Businesses entries between 1st July 2011 and 1st May 2016

Figure 6-28 Retail Trade: Employment Trend Lines (Working Residents)





Figure 6-29 Retail Trade - Resident Working Population, Top 5 LGA 's of Usual work



Employment in 'Retail Trade' in Knox is support by an estimated 708 businesses within the Knox LGA which are currently trading with registered ABNs and listed for GST (Figure 6-6). It is noted that ABR data does not yet include all branch locations of major national trading businesses which has implications for business counts at an LGA level.




Figure 6-31 Retail Trade: New Businesses entries between 1st July 2011 and 1st May 2016




Figure 6-32 Accommodation and Food Services: Employment Trend Lines (Working Residents)




Figure 6-34 Accommodation and Food Services – Jobs in Knox by Top 5 LGAs of Usual Residence






Figure 6-37 Transport, Postal and Warehousing: Employment Trend Lines (Working Residents)



Figure 6-38 Transport, Postal and Warehousing Sector - Resident Working Population, Top 5 LGA 's of Usual work








Figure 6-41 Information Media and Telecommunications: Employment Trend Lines (Working Residents)



Figure 6-42 Information Media and Telecommunications Sector: Resident Working Population, Top 5 LGA 's of Usual work





Figure 6-45 Financial and Insurance Services: Employment Trend Lines (Working Residents)






Figure 6-46 Financial and Insurance Services Sector - Resident Working Population, Top 5 LGA 's of Usual work




Figure 6-47 Financial & Insurance Services sector – Jobs in Knox by Top 5 LGAs of Usual Residence






Figure 6-50 Rental, Hiring and Real Estate Services: Employment Trend Lines (Working Residents)



Figure 6-51 Rental, Hiring and Real Estate Sector - Resident Working Population, Top 5 LGA 's of Usual work






Figure 6-55 Professional Scientific and Technical Services: Employment Trend Lines (Working Residents)







Figure 6-59 Administrative and Support Services: Employment Trend Lines (Working Residents)





Figure 6-60 Administrative and Support Services Sector - Resident Working Population, Top 5 LGA 's of Usual work










Figure 6-65 Public Administration and Safety sector – Jobs in Knox (C) by Top 5 LGAs of Usual Residence






Figure 6-67 Education and Training: Employment Trend Lines (Working Residents)




Figure 6-68 Education & Training Sector - Resident Working Population, Top 5 LGA 's of Usual work






Figure 6-71 Health Care and Social Assistance: Employment Trend Lines (Working Residents)



Figure 6-72 Health Care and Social Assistance Sector - Resident Working Population, Top 5 LGA 's of Usual work








Figure 6-74 Health Care & Social Assistance Sector: New Businesses entries between 1st July 2011 and 1st May 2016

By 2036 it is forecast that there will be 9,025 'Health Care & Social Assistance' sector jobs based in Knox, which represents a 46.2 percent increase from 2011 levels. Employment forecasts for the Health Care and Social Assistance sector indicate between 300 and 640 new jobs in Knox will be created in the sector every 4 years; equating to over 2,000 new jobs in the sector over the next 20 years.

While the projected growth over this 20-year period is in line with population and ageing forecasts, there is a possibility that catalytic projects such as the Wantirna Health Assessment Area could alter the rate of growth during the initial 10 years.

6.1.35 Arts and Recreation (working residents)

In 2011, there were 1,011 Knox residents employed in the 'Arts and Recreation' industry sector. 2021 employment is estimated to be 1,259 jobs. By 2036 the number of jobs is projected to increase to 1,456, reflecting population growth increasing demand for cultural experiences.




Figure 6-76 Arts and Recreation: Employment Trend Lines (Working Residents)



The place of usual residence forecasts presented above provides a key input into generating projections of the number of jobs based in Knox in the 'Arts and Recreation' sector. The greater the number of residents working in this sector whose job is also based in Knox, the greater the influence of the place of usual residence forecasts on the place of work employment projections. The following analysis from the ABS 2011 Census provides some insights into where local workers in this industry sector reside.

There are 1,011 local Knox residents working in the 'Arts and Recreation' sectors, and these people are predominantly associated with employment in Sports & Recreation. Residents who work in the sector and are employed in Knox represent (31.0 %) of these workers. Other key locations for workers in the sector include: Melbourne (21.0 %), Other locations (9.6 %), Monash (8.1 %) and Yarra Ranges (5.2 %).

Figure 6-77 Top 5 LGA 's of Usual work, Residents in Knox (C) who work in Arts & Recreation Services Sector





6.1.36 Arts & Recreation (jobs in Knox)

In 2011, there were 665 'Arts and Recreation' industry sector jobs in Knox. By 2021 employment is estimated to be 850 jobs. By 2036 the number of jobs is projected to be 1,011, reflecting a strong growth outlook, off a small base in the context of Knox.

The figure below illustrates where local workers in the 'Arts and Recreation' industry sector reside.

Historical data indicates that the sector's workforce expanded between 2006 and 2011 Census years resulting in an overall increase of 28 jobs (4%).

Employment in 'Arts and Recreation' in Knox is support by an estimated 149 businesses within the Knox LGA which are currently trading with registered ABNs and listed for GST. During the last five years, 36 new business entries have contributed to employment growth in the sector. The key sectors generating new business opportunities within the sector locally include: Creative Artists, Musicians, Writers and Performers and Health and Fitness Centres and Gymnasia Operation (Figure 6-79).

6.1.37 Other Services (working residents)

In 2011, there were 3,418 Knox residents employed in the 'Other Services' industry sector. 2021 employment is estimated to be 3,636 jobs. By 2036 the number of jobs is projected to increase to 3,714, reflecting strong population growth with associated demand for personal and other services which includes:




Figure 6-81 Other Services: Employment Trend Lines (Working Residents)



The place of usual residence forecasts presented above provides a key input into generating projections of the number of jobs based in Knox in the 'Other Services' sector. The greater the number of residents working in this sector whose job is also based in Knox, the greater the influence of the place of usual residence forecasts on the place of work employment projections. The following analysis from the ABS 2011 Census provides some insights into where local workers in this industry sector reside.

The *Other Services* sector contributes 3,418 jobs (4.5%) to total employment for the working resident population in Knox. Of residents working in the sector, 1,153 work in Knox (33.7%). Other key locations including Whitehorse (10.7%) and Monash (9.5%) also provide employment for Knox residents who work in the sector.

Figure 6-82 Top 5 LGA 's of Usual work, Residents in Knox (C) who work in Other Services Sector





6.1.38 Other Services (jobs in Knox)

In 2011, there were 2,401 'Other Services' industry sector jobs in Knox. By 2021 employment is estimated to be 2,622 jobs. By 2036 the number of jobs is projected to be 2,754, reflecting a stable to low-growth outlook, off a very small base in the context of Knox.

The figure below illustrates where local workers in the 'Other Services' industry sector reside.

Employment in 'Other Services' in Knox is support by an estimated 710 businesses within the Knox LGA which are currently trading with registered ABNs and listed for GST. During the last five years, 187 new business entries have contributed to employment growth in the sector. Notable sectors where new business creation has occurred includes: Automotive Body, Paint and Interior Repair, Other Automotive Repair and Maintenance, Hairdressing and Beauty Services (Figure 6-84).

By 2031 it is forecast that there will be 2,754 'Other Services' sector jobs based in Knox, which represents a 14.7 percent increase from 2011 levels. It is predicted that the 'Other Services' sector will grow broadly in line with population forecasts.

7 Summary & Conclusion

The Land for Business Employment Projections 2016 - 2036 report seeks to outline employment forecasts within the Knox (C) Local Government Area (LGA). The report provides industry context and integrates previous reporting, feedback from stakeholder engagement, notable industry trends and spatial analysis for the LFB Assessment Areas.

Victoria in the Future and id population forecasts, and the REMPLAN Workforce Module have been applied to build an understanding of future residential populations, broken down by age cohort. Different age cohorts have varying propensities to be engaged in the workforce, and there are also observable patterns in terms of employment by industry sector for respective age cohorts. For instance, young people are far more likely to be employed in sectors such as retail and food services, whereas older workers are more likely to be employed in sectors such as manufacturing, health, education and professional services.

There are also notable patterns across respective industry sectors in terms of where residents travel to for work, and where people working in Knox reside. A broad observation is that the higher typical income levels are in a sector, the further people are prepared to travel between home and work.

Population projections by age in Knox and the surrounding Melbourne East Region, propensities to work by age cohort, complex patterns of people living in one area and working in another, structural shifts in employment over time, as well as broader strategic and situational analysis have been applied to generate 2 types of employment forecasts for Knox:

- 1. Employment Forecasts to 2036 Working Residents
- 2. Employment Forecasts to 2036 Jobs in Knox.




Figure 7-1 Employment Forecasts - Working Residents

Between 2011 and 2036 it is forecast that there will be 16,883 additional working residents in Knox, an increase of 22.3 percent over this timeframe.




Figure 7-2 Employment Forecasts - Jobs in Knox

Between 2011 and 2036 it is forecast that there will be 15,142 additional jobs in Knox, an increase of 27.1 percent over this timeframe.

This key project input provides the basis for further assessment of land use implications across the Knox Land for Business Assessment Areas. There is a need to undertake further reconciliation of existing and future land use constraints and opportunities. Changes employment and workforce location is an important consideration for some sectors. While most employment in the Knox LGA is located in the Assessment Area subject to the Land for Business Project it is expected that transition and change in sectors will influence the demand for business land at a varying degree.

Integration of spatial analysis and the workforce projections within this report will be critical in determining recommendations for future land for business within Knox.
