Prevention of Cruelty to Animals Act 1986

Instrument of Delegation

I, Simon Phemister, Department Head of the Department of Jobs, Precincts and Regions, pursuant to the power of delegation in section 38(2) of the *Prevention of Cruelty to Animals Act 1986* (the Act), delegate to all persons or class of persons holding, occupying or performing the duties of the positions specified in Column 1 all the powers, duties and functions under the Act specified in Column 2 and described in Column 3 of the Table in the Schedule to this Instrument of Delegation. All delegated powers, duties and functions under this instrument are subject to any conditions specified in Column 4 of the Table in Schedule 1 to the Instrument of Delegation.

The descriptions in Column 3 of the Table in the Schedule are for convenience only and do not affect the nature or extent of the power, duty or function to which the description refers and do not impose any special conditions on the exercise of the powers, duties or functions.

I revoke the previous Instrument of Delegation under section 38(2) of the Act, dated 5 November 2020.

This Instrument of Delegation commences on signing.

Definitions

The following definitions apply in this Instrument:

- Chief Commissioner means the Chief Commissioner of Police appointed under section 17 of the Victoria Police Act 2013.
- Chief Executive Officer, Council has the same meaning as Chief Executive Officer in section 5 of the Local Government Act 1989.
- Director of Legal Services means the Director of Legal Services, Victoria Police.
- **DELWP** means Department of Environment, Land, Water and Planning.
- **POCTA Inspector** means a general inspector or a specialist inspector within the meaning of the **Prevention of Cruelty to Animals Act 1986**.
- Regulations means the Prevention of Cruelty to Animals Regulations 2019.
- RSPCA Victoria means the Royal Society for the Prevention of Cruelty to Animals (Victoria).
- Senior Police Officers means any police officer within the meaning of the Victoria Police Act 2013 of the rank of Chief Commissioner, Deputy Commissioner, Assistant Commissioner, commander, chief superintendent, superintendent, chief inspector or inspector, all ranks having the same meaning as defined in the Victoria Police Act 2013.
